WELCOME ADDRESS

Hon. Peggy Serame, Minister of Finance of Botswana

Peggy Onkutlwile Serame, Minister, Ministry of Finance (Formerly, Ministry of Finance and Economic Development).

Ms. Serame became Minister of Finance and Economic Development in April 2021. Before then she served as Minister of Trade and Industry (MITI) from November 2019 to April 2021. She holds a master's degree in economics (Electives on International Trade; Policy Analysis and Economic Management) and a BA degree in Economics and Statistics from the University of Botswana. Before joining the ministry, she was Director of Macroeconomic Policy Section, Economic and Financial Policy Division in the Ministry of Finance and Economic Development, and briefly as the immediate past Acting Deputy Permanent Secretary to the President.

SESSION I: Keynote Addresses: A Framework to Win the Fight Against Corruption in Good Times and in Bad Times

Keynote Address I

H.E. Dr. Monique Nsanzabaganwa, Deputy Chairperson (DCP) African Union Commission (AUC)

H.E. Dr. Monique Nsanzabaganwa Is the Deputy Chairperson (DCP) for the African Union Commission. She is in charge of Administration and Finance and assists the Chairperson in the execution of his functions to ensure the smooth running of the Commission, and acts as the Chairperson in his absence.

Dr. Nsanzabaganwa holds a Ph.D. in Economics, and Honorary Doctorate of Commerce, University of Stellenbosch. She has over twenty years' experience developing and leading programs that drive financial inclusion and economic prosperity. Prior to her election she held senior positions in the Government of the Republic of Rwanda including Minister of State in charge of Economic Planning, Minister of Trade and Industry and Deputy Governor of the Central Bank. Dr. Nsanzabaganwa has supported various Gender Empowerment initiatives through her memberships in the Alliance



for Financial Inclusion Gender committee, Women's World Banking African Advisory Council, the Graça Machel Trust Expert Group on women's financial inclusion and the digital economy in Africa, New Faces New Voices Rwanda chapter, Unity Club amongst others.

Dr. Nsanzabaganwa was elected by the 34th African Union Assembly for a four-year term renewable once. She is the first woman to hold the position of Deputy Chairperson of the African Union Commission.

Keynote Address II

Ms. Antoinette Monsio Sayeh, Deputy Managing Director, International Monetary Fund (IMF)

Before assuming her new role at the IMF, **Antoinette Monsio Sayeh** was a Distinguished Visiting Fellow at the Center for Global Development (CGD) and Co-Chair for the recently concluded 19th Replenishment of the International Development Association (IDA19), the World Bank's Fund for the poorest. She previously oversaw and significantly enhanced the International Monetary Fund's engagement with its sub-Saharan African members as Director of the African Department between July 2008 and August 2016.



As Minister of Finance in post-conflict Liberia (January 2006 through June 2008), she led the country through the clearance of its long-standing multilateral debt arrears, the HIPC Decision Point, the Paris Club, and its first Poverty Reduction Strategy, significantly strengthening its public finances and championing public financial management reform. Before joining President Ellen Johnson Sirleaf's Cabinet, Ms. Sayeh worked for the World Bank for 17 years, including as Country Director for Benin, Niger, and Togo; Senior Country Economist for Pakistan and Afghanistan, as well as an Advisor in the Bank's Operations Policy Vice Presidency and as Assistant to its principal Managing

Director. Before joining the Bank, Ms. Sayeh worked in economic advisory positions in Liberia's Ministries of Finance and Planning.

Ms. Sayeh graduated with a bachelor's degree with honors in economics from Swarthmore College and a PhD in International Economic Relations from the Fletcher School at Tufts University. While at CGD, Ms. Sayeh has also served on the Board of Managers of Swarthmore College; Board of Directors of the Ellen Johnson Sirleaf Presidential Center for Women and Development; and Board of Directors of Emerging Public Leaders.

SESSION II: Reaping the Governance Dividend in Africa

Speaker:

H.E. Ellen Johnson Sirleaf, Former President of Liberia

Internationally known as "Africa's Iron Lady," Nobel Laureate Ellen Johnson Sirleaf is a leading promoter of freedom, peace, justice, women's empowerment and democratic rule. As Africa's first democratically-elected female head of state, she has led Liberia through reconciliation and recovery following the nation's decade-long civil war, as well as the Ebola Crisis, winning international acclaim for achieving economic, social, and political change. Recognized as a global leader for women's empowerment, President Sirleaf was awarded the



prestigious Nobel Prize for Peace in 2011. She is the recipient of The Presidential Medal of Freedom—the United States' highest civilian award—for her personal courage and unwavering commitment to expanding freedom and improving the lives of Africans. Her many honors also include the Grand Croix of the Légion d'Honneur, France's highest public distinction, and being named one of Forbes's "100 Most Powerful Women in the World."

And in 2017, former President Sirleaf was awarded the Mo Ibrahim Prize for Achievement in African Leadership, which celebrates excellence in African leadership. The Ibrahim Prize recognizes leaders who, during their time in office, have developed their countries, strengthened democracy and human rights for the shared benefit of their people, and advanced sustainable development. Sirleaf was the first female recipient.

President Sirleaf was elected President of the Republic of Liberia in 2005, two years after the nation's bloody civil war ended. Her historic inauguration as Africa's first democratically elected head of state took place on January 16, 2006. Prior to the election, she had served in the transitional government, where she chaired the Governance Reform Commission and led the country's anti-corruption reform. She won reelection in November 2011.

During her two terms as president, Johnson Sirleaf has focused on rebuilding the country, attracting over \$16 billion in foreign direct investment. She has also attracted more than \$5 million in private resources to rebuild schools, clinics and markets, and fund scholarships for capacity building. She successfully negotiated \$4.6 billion in external debt forgiveness and the lifting of UN trade sanctions, which have allowed Liberia to once again access international markets. She increased the national budget from \$80 million in 2006 to over \$672 million in 2012, with an annual GDP growth rate of more than 7%.

In June 2016, President Sirleaf was elected the first female Chairperson of the Economic Community of West African States (ECOWAS) for a twelve-month term. In May 2012, she was appointed co-chair of the United Nations Secretary

General's High-Level Panel of Eminent Persons on the Post-2015 Development Agenda. The panel is tasked with crafting a roadmap for global recovery and sustainable development.

President Sirleaf began her career in the Treasury Department in Liberia in 1965. In 1979, she rose to the position of Minister of Finance and introduced measures to curb the mismanagement of government finances. After the 1980 military coup d'état, she became president of the Liberian Bank for Development and Investment, but fled Liberia that same year, escaping an increasingly suppressive military government. Johnson Sirleaf has also served as vice president of Citicorp's Africa regional office in Nairobi, as senior loan officer at the World Bank, and as a vice president for Equator Bank.

Prior to her first campaign for the presidency, Johnson Sirleaf served as assistant administrator of the United Nations Development Programme and as director of its Regional Bureau of Africa, with the rank of assistant secretary-general of the United Nations, a post she resigned to contest the 1997 presidential elections. After coming in second, she went into self-imposed exile in neighboring Cote d'Ivoire (Ivory Coast). While in exile, she established a venture capital vehicle for African entrepreneurs and founded Measuagoon, a Liberian community development NGO.

President Sirleaf has been awarded honorary doctorates by more than 15 institutions, including: Tilburg University (Netherlands), the Nigerian Defence Academy, the University of Massachusetts Medical School, Harvard University, Rutgers University, Yale University, Georgetown University, the University of Abeokuta (Nigeria), the University of Minnesota, Furman University of South Carolina, Brown University, Indiana University, Dartmouth College, Concordia University, Langston University, Spelman College and Marquette University.

In addition to her Nobel Prize, President Sirleaf is the recipient of numerous honors, including: the Indira Gandhi Prize for Peace Disarmament and Development (2012), the African Gender Award (2011), Friend of the Media Award (2010), FUECH Grand Cross Award (2009), FAO's CERES Medal (2008), Golden Plate Award (2008), International Women's Leadership Award (2008), International Crisis Group Fred Cuny Award for the Prevention of Deadly Crisis (2008); James and Eunice K. Matthews Bridge Building Award (2008), American Academy of Achievement Golden Plate Award (2008), National Civil Rights Museum Annual Freedom Award (2007), National Democratic Institute Harriman Award (2007), Bishop T. Walker Humanitarian Award (2007), Gold Medal of the President of the Italian Republic (2006), Africa Prize for Leadership for the Sustainable End of Hunger (2006), National Reconciliation Award (2006), International Woman of the Year (2006), and International Republican Institute Freedom Award (2006).

President Sirleaf has been ranked among the top 100 most powerful women in the world (Forbes, 2012), the most powerful woman in Africa (Forbes Africa, 2011), one of six "Women of the Year" (Glamour, 2010), among the 10 best leaders in the world (Newsweek, 2010) and top 10 female leaders (TIME, 2010). In 2010, The Economist called her "the best President the country has ever had."

Born Ellen Eugenia Johnson, President Sirleaf is the granddaughter of a traditional chief of renown in western Liberia and a market woman from the southeast. U.S. educated, she holds a master's in public administration (MPA) from Harvard University's Kennedy School of Government. She also earned a degree in accounting at Madison Business College in Wisconsin and received a diploma from the University of Colorado's Economics Institute.

President Sirleaf has written widely on financial, development and human rights issues, and in 2008 she published her critically acclaimed memoir, This Child Will Be Great.

She is the proud mother of four sons and grandmother of 12.

Prof. Eddy Maloka, CEO, African Peer Review Mechanism

Prof Eddy Maloka is the CEO of the African Peer Review Mechanism (APRM), an organ of the African Union responsible for promoting good governance on our continent, and a Visiting Professor at the University of Witwatersrand's School of Governance, Public and Development Management in South Africa.

He was the Chairperson of the African Governance Architecture (AGA), a platform for dialogue among AU institutions with the mandate to promote good governance and strengthen democracy in Africa, and formerly the President of the Convocation of the University of Cape Town.

His other previous appointments include: Special Advisor to the Minister of International Relations and Cooperation in the Republic of South



Africa; South Africa's Special Representative to the Great Lakes Region; Special Advisor to the Deputy President of the Republic of South Africa; and Advisor on Governance, Public Administration and Post-Conflict Reconstruction to the New Partnership for Africa's Development (NEPAD).

Prof Maloka holds a Bachelor of Arts Degree from Rhodes University (South Africa); a Master Degree in Development Studies from the Geneva-based Institute of Development Studies, in Switzerland; and a Ph.D in History from the University of Cape Town.

He was a Post-Doctoral Fellow at Princeton University, in New Jersey, the USA; and a Research Fellow at the School of Oriental and African Studies (SOAS), the University of London.

He served as President of the Association of African Political Science (AAPS), and the President of the South African Association of Political Science.

He is a widely published scholar with interest in African and international affairs.

Dr. Frannie Leautier, CEO, SouthBridge Group

Dr. **Frannie Léautie**r, Senior Partner at SouthBridge Group and CEO of SouthBridge Invest-ments, is a highly experienced and well-known finance and development expert, with long-standing global experience leading and transforming organisations in the private, public and non-for-profit spheres.

Dr. Léautier had an illustrious career at the World Bank Group (WBG), where during her 15-year tenure, she held senior financial positions across the Group. Frannie was Chief of Staff to the President, and served as Vice-President for seven years of her tenure at the WBG. She was Infrastructure Director and played a critical role in the strategic work around the joint World Bank/IFC infrastructure products and played a crucial role in developing the WBG's infrastructure strategy. At the WBG, she won



several awards for her outstanding support and contributions. She was Senior Vice President and Chief Operating Officer at the African Development Bank (AfDB) and chaired the AfDB Board for much of the time she was there. She has held several leadership roles at the Trade and Development Bank (TDB) Group, in-cluding Vice Chair of the

Board, Special Advisor to the President, before becoming TDB's first Chief Operating Officer. She also led the Asset Management business of TDB, including the recent launch of a unique product for trade finance in Africa.

She has founded two companies, one in Risk Management Advisory and another to invest equity into SMEs. In addition to her extensive career, Dr. Léautier holds advisory and gov-ernance roles on several boards, including the UN Foundation, where she is a member of the Board and serves on the Program Committee and Nominating Committee; Orca Energy Group, a Toronto Exchange publicly listed company, where she is member of the Risk and Audit Committee and chairs the ESG Committee; chair of the board of Norsad Finance Ltd; member of the Executive Board at AZA Finance, a cross-border payments platform; chair of the Board of FSD-Africa and FSD-Africa Investments; trustee at ODI; and is a member of the board of Les Eaux Minérales d'Oulmes, where she sits on the Audit and Risk Committee. She is also a member of the Board of World Resources Institute (WRI). She is a member of the World Economic Forum's (WEF) Regional Advisory Group for Africa and has previously served as co-Chair for the Global Agenda Councils of the WEF on youth unemployment and also for Africa. Other advisory and board roles she has held include with MIT, OCP Group, African Economic Research Consortium (AERC) where she was Treasurer and also chaired the Audit and Risk Committee, Institute for Security Studies (ISS), King Badouin Foundation US (KBFUS), and Nelson Mandela Institute for Science and Technology (NM-AIST). She has authored several books including "Leadership in a Globalized World: Complexity, Dynamics and Risk" and articles in prestigious journals. She was distinguished professor at Sciences Po Paris, and has lectured at MIT where she developed a course on infrastructure systems. She has also been invited to lecture at Harvard and the University of Tokyo. She holds a Masters of Science in Transportation, and a PhD in Engineering (thesis on Infrastructure Systems) from MIT. She also holds a doctorate in Humane Letters from North Central College and a doctorate in Law from Lancaster University, honoris causa.

His undergraduate and post-graduate qualifications cover public administration/policy, politics and economics.


Mr. Emeka Jude Phillipe Obegolu, President of the Executive Committee of the Pan African Lawyers' Union

Prof. Elizabeth David-Barrett, University of Sussex

Prof. Liz David-Barrett is Head of the Global Programme on Measuring Corruption at the International Anti-Corruption Academy. She is on leave from the University of Sussex, which she joined in 2014 and where she was Director of the Centre for the Study of Corruption from 2018 to 2022. Prof David-Barrett has published her research on ethics in public office, corruption risks in public procurement, and business integrity, in top-tier academic journals. She engages widely with policy-makers and practitioners – for example, she chaired the first Academic Roundtable of the G20 Anti-

SESSION VIII: Fiscal Governance and Vulnerabilities to Corruption

Vera Songwe is the Under Secretary-General of the United Nations and Executive Secretary of the Economic Commission for Africa (ECA). Following her appointment, she became the first woman to lead the institution in the organisation's history and the highest-ranking United Nations regional official.

As a leading figure on Africa's development issues, Songwe's reforms have focused on developing and implementing "ideas for a prosperous Africa", with critical emphasis on macroeconomic stability, innovative finance, private sector participation, the digital transformation, and trade and competitiveness in fostering growth and improving livelihoods.

She was listed as one of Africa's 50 most powerful women by Forbes in 2020 and named as one of the '100 Most Influential Africans' by Jeune Afrique in 2019. In 2017, New African

Magazine listed her as one of the '100 Most Influential Africans' and the FT named her one of the '25 African to watch' in 2015.

Songwe is acknowledged for her long-standing track record of providing policy advice and her wealth of experience in delivering development results for Africa. She has written extensively on development and economic issues including on debt, infrastructure development, fiscal and governance issues. She is well published and contributes to the development debate across a broad spectrum of platforms including in the Financial Times.

Prior to ECA, she held a number of senior leadership roles with the International Finance Corporation and World Bank.
