The CMTT has proposed a set of consistent frameworks for economies to indicate the degree of alignment of their national compilation practices with the system of System of National Accounts (SNA), Balance of Payments and International Investment Position (BPM), and Government Finance Statistics (GFSM). The proposed frameworks are intended to provide structured, systematic, and consistent methods to measure an economy's alignment to these statistical standards.

The degree of alignment communicates to users: (i) information about the quality of cross-country comparisons and assist in making appropriate adjustments to achieve comparability in their analyses; (ii) the extent to which major revisions should be expected in the future, such as in cases where an economy statistical compilation is not fully aligned with the international standards, and; (iii) finally it helps producers of statistics to identify areas for improvement, prioritize resources, and formulate strategic plans etc.
