##### **Maiava Atalina Emma Ainuu-Enari, Governor, Central Bank of Samoa**



Maiava Atalina Emma Ainuu-Enari was appointed Governor and Chairperson of the Board of the Central Bank of Samoa (CBS) on 11 August 2011, the first woman to hold this role. A career central banker, having worked for the CBS for a cumulative period of 30 years, and held a number of senior positions within the Bank. Ms Ainuu-Enari has extensive experience in macroeconomic policy development and implementation, monetary policy formulation and implementation, reserve and liquidity management, financial intelligence and enforcement and banking and insurance supervision. A strong champion of financial inclusion and inclusive development for sustainable growth.

Ms Ainuu-Enari is also an Accredited Mediator since 2017 and is a member of the Accredited Mediators of Samoa Association (AMSA).

On the international front, she currently holds the following positions:

- Co-Chair of the Operations Committee of the Asia Pacific Group on Money Laundering (APG)
- Member of the United Nations Secretary General's Task Force on Digital Financing of the Sustainable Development Goals (SDG's)
- Former Board member of the Alliance for Financial Inclusion (AFI)

Ms Enari is an Economist and Lawyer and holds a Bachelor of Business in Economics, Banking and Finance from University of Southern Queensland (Australia), a Master of Science in International Economics, Banking and Finance from the University of Wales (UK), and a Bachelor of Law (LLB), Professional Diploma in Legal Practice (PDLP) and a Professional Diploma in Legal Drafting (PDL) from the University of the South Pacific (Fiji and Vanuatu).

##### **Ravi Menon, Managing Director, Monetary Authority of Singapore**



Mr Ravi Menon was appointed Managing Director of the Monetary Authority of Singapore (MAS) in 2011. He was previously Permanent Secretary at the Ministry of Trade & Industry (MTI) and Deputy Secretary at the Ministry of Finance (MOF).

Mr Menon began his career at MAS in 1987. During his 16 years in MAS, he was involved in monetary policy; econometric forecasting; organisational development; banking regulation and liberalisation; and integrated supervision of complex financial institutions. Mr Menon

spent a year at the Bank for International Settlements in Basel, as a member of the secretariat to the Financial Stability Forum. A recipient of the Singapore Government's Meritorious Service Medal and Public Administration (Gold) Medal, Mr Menon has served on a variety of boards in the public, private, and people sectors in Singapore. On the international front, Mr Menon chairs the Network of Central Banks and Supervisors for Greening the Financial System. He is also a member of the Financial Stability Board (FSB) Steering Committee. Mr Menon holds a Master's in Public Administration from Harvard University and a Bachelor of Social Science (Honours) in Economics from the National University of Singapore.

### **Nor Shamsiah, Governor, Bank Negara Malaysia**



Ms. Nor Shamsiah is the Governor of Bank Negara Malaysia (BNM). As Governor, she chairs BNM's Board of Directors, as well as other committees such as the Monetary Policy Committee and Financial Stability Committee. She assumed office on 1 July 2018.

Shamsiah joined BNM in 1987 and has served in and overseen various functions across the Bank. These include financial regulations and supervision, financial intelligence and enforcement, talent management, and finance. During the Asian financial crisis, Shamsiah was a key member of the team involved in resolving financial institutions. As Deputy Governor, she also represented BNM at international fora, such as the Basel Committee on

Banking Supervision and the Financial Action Task Force.

Prior to her appointment as Governor, Shamsiah also served as Assistant Director of the Monetary and Capital Markets Division of the IMF.

#### **Haslinda Amin, Chief International Correspondent for Southeast Asia and anchor, Bloomberg**



Haslinda Amin is Chief International Correspondent for Southeast Asia and anchor for Bloomberg Television. She is also host and Executive Producer of talk show 'High Flyers' which is the longest-running program on Bloomberg TV.

Based in Singapore, Amin has been at the heart of market-moving news and stories that have driven the region's transformation. She has reported on major events including the 2008 financial crisis, several elections across Asia including India and Indonesia which are among the world's most populous, the 2016 Jakarta attacks and the 2010 bloody anti-government clashes in Thailand. Amin has also helped Bloomberg's coverage of the Asia-Pacific Economic Cooperation meeting, the World Economic Forum, the Asian Infrastructure Investment Bank

Board of Governors Meeting and the ASEAN Milken Global Summit. Amin has interviewed a wide range of top newsmakers for Bloomberg Television.

Amin began her career covering Southeast Asian politics more than a decade ago. She serves on the board of UN Women Singapore and has been nominated numerous times for Best Current Affairs Anchor at the Asian TV Awards. She graduated from the National University of Singapore, majoring in Political Science and English Language. She speaks Bahasa Indonesia.
