Task Teams

Task Teams : Overview

- Research agenda requires teams of experts to research each topic and prepare recommendations for GFSM update
- Update to SNA and BPM has effectively used task teams to develop guidance and recommendations
- Task teams have been the vehicle for:
 - drafting guidance notes
 - preparing options for new guidance
 - discussing and agreeing recommendations
- **Proposed that the GFSM update adopts a similar approach**

Task Teams : Governance – Role of Chair

- Chairs of task teams:
 - appointed by the IMF, based on experience and expertise
 - may be selected from the IMF, GFSAC, international / regional organizations, country authorities, independent experts
 - participate in selection of task team members
 - report regularly to the GFSAC on task team activities
 - establish subgroups for each research topic
 - set and monitor timelines for advancing each research topic
 - chair task team meetings and oversee consultations

Task Teams : Governance – Role of Secretariat

- Secretariat of task teams:
 - to be provided by the IMF
 - schedule task team meetings (as required by the Chair)
 - prepare draft minutes of task team meetings
 - administer consultations within task teams
- working language of task teams to be English

Task Teams : Governance – Role of subgroups

- Subgroups of task teams:
 - technical team to prepare new guidance and recommendations on a specific research topic
 - subgroup members are generally also part of wider task team
 - although where necessary topic experts may be selected by task team Chair to participate in subgroups only
 - prepare guidance notes – following standard structure
 - advance research topics in accordance with timeline set by the task team Chair
 - present draft guidance notes and updates to wider task team / GFSAC
 - may choose their preferred method(s) of collaborative working

Task Teams : Membership

- Task teams to be large enough to advance all research topics but small enough to allow for effective decision making
- Task team membership to seek a balance between IOs, country authorities (users and compilers) and independent experts
- Task team membership to seek a geographical balance
- Task team membership may include experts from other macroeconomic statistical domains, accountancy profession, and academia
- Proposed to limit task teams to 20 members, but some flexibility may be necessary as number of research topics will vary by task team
- Members of task teams will not be remunerated in any way
- ❖ **Does GFSAC agree with the proposed governance and membership of task teams?**

Task Teams : Terms of reference

- Draft Terms of Reference are included in document on process and timeline
 - includes most of the above proposals on governance and membership
 - also mentions that task teams should strive to reach a consensus on recommendations and if not possible then the different views should be presented in the guidance note – likely a need to expand to include a dispute resolution mechanism (as in SNA/BPM task teams)
- Draft standard structure for guidance notes also included

 2. Debt and other monetary and financial topics (including experts from MFS update)
 3. Environmental topics (including experts from SEEA-CF update)
