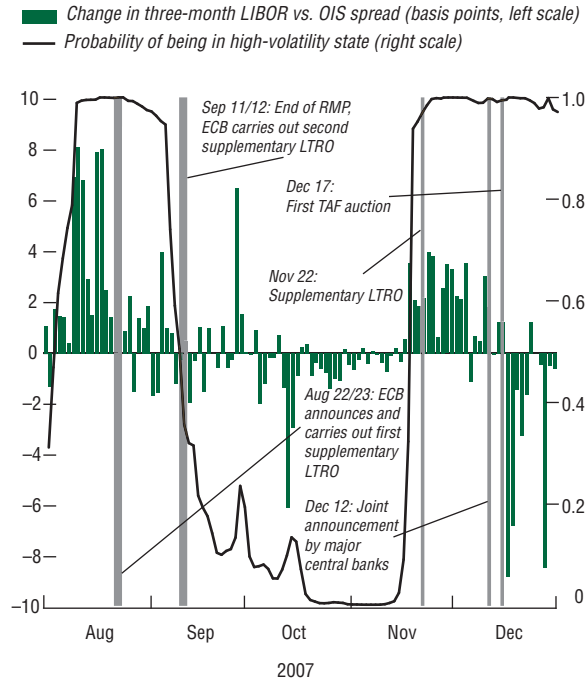


Figure 3.11. Euro Area: Selected European Central Bank Policy Actions and Term Funding Stress

These data are used in the estimation of a three-state Markov Switching ARCH model. The black line provides the subsequent probability of being in the highest volatility regime, which is determined by the variation in the LIBOR spread. The probabilities of being in the medium- and low-volatility states are not shown here. The gray bars indicate selected major central bank interventions. OIS = overnight index swap; RMP = reserve maintenance period; ECB = European Central Bank; LTRO = long-term refinancing operations; TAF = Term Auction Facility.
